Crates, Shipping, and any additional handling expenses will be paid by, and are, the responsibility of the Buyer.

### **TERMS AND CONDITIONS**

The Seller represents:

The above puppy has been examined by a licensed Veterinarian and was found to be in good health.

This puppy is being sold as a pet and companion animal. The application for registration of this puppy is limited (\*) and this puppy is not being sold for the purposes of breeding.

**\*Limited Registration** means that the dog is registered but no litters produced by the dog are eligible for registration. Dogs with limited registration may **not** be entered in breed competition at Dog Shows but may compete in all other AKC events.

Reasonable precautions have been taken to prevent this puppy from acquiring hereditary defects of the hips, eyes and heart. However, due to unknown hereditary and environmental causes of such defects, no guarantee will be given against them. Should said puppy be diagnosed by a board certified specialist as being affected by one of the above defects, the Sellers will, at their discretion, take the puppy back and replace it with a puppy from another breeding within two years for hips and one year for all other genetic defects, or buyer(s) may choose to keep the puppy and accept all responsibilities. No monetary refunds will be given and the seller reserves the right to have a second vet of choice evaluate the condition before any exchange will be issued. The buyer(s) is responsible for all transportation and/or shipping costs to replace the puppy and seller is not responsible for any veterinary expenses related to the certification that the animal is unfit or otherwise.

**THE FOLLOWING APPLIES ONLY TO THE ORIGINAL BUYER:**

The Buyer(s) Agree(s):

This puppy will be examined by a licensed veterinarian within 72 hours of receipt. If the puppy is returned due to illness, a verified letter from the veterinarian is required. This includes death or illness from any health condition deemed present prior to removal from original premises. Buyer(s) understands that the following slight, genetic defects are not considered serious or life threatening and therefore are not covered under the guarantee: umbilical hernia, inguinal hernia, cherry eye, undescended testical, under bite or over bite, and grade 1 or 2 patellas. This guarantee also does not cover Hypoglycemia, Coccidiosis, Kennel Cough, Giardia, mites, ticks, ringworm, or ear infections once the puppy has left the sellers hands due to these being caused by stress of moving or can be easily picked up during travel. The seller assumes no responsibility (of said puppy after the puppy leaves the sellers premises) for medical expenses, disease, mortality, landlord disapproval, allergies, disagreement of the family, or any other reasons. Under no circumstances is the seller responsible for any veterinarian bills or shipping incurred with the puppy after time of sale. In cases of a legal dispute between parties the buyer is responsible for any and all legal fees for both sides (buyer and seller.)

That said dog will be given proper medical care including, but not limited to, vaccinations and annual boosters, regular deworming, adequate and proper shade and housing in a fenced yard or kennel. That the Buyer will groom, train and care for this dog in a manner consistent with high quality animal husbandry practices and those endorsed by the Breeder and the Golden Retriever Club of America.

That the Buyer will use the prefix **Snowypine's** at the beginning of the dog's registered name along with any other specific themes or words requested by the Breeder.

That this dog will not be used for any purposes of research or vivisection and shall not be sold or given to any wholesale establishment, chain store, catalog sales house, pet store or puppy mill. That this dog will **never** be surrendered to any humane society, animal rescue group or animal shelter.
